**ORDER NO. 2018-028**

Legalization of a Portion of SW Hewett Boulevard, as County Road No. 5025.

**The Multnomah County Board of Commissioners Finds:**

- a. SW Hewett Boulevard was established as County Road No. 405 in 1886 and portions of the road cannot be accurately determined due to numerous alterations of the road, historically conflicting and/or defective surveys of the road or adjacent property, and the road as traveled and used for the last ten years does not conform to the existing records for this county road.
- b. SW Hewett Boulevard has been traveled and used by the public and maintained by the County for more than 25 years.
- c. On December 21, 2017, the Board of Commissioners adopted Resolution No. 2017-103 initiating proceedings for legalizing a portion of SW Hewett Boulevard, from SW Grant Street southeasterly, about 1,800 feet to SW 54th Avenue in its travelled location and as more particularly described in the attached Exhibit A ("the Road"), and directed the County Surveyor to conduct a survey of the Road.
- d. On January 25, 2018, the County Engineer caused a written report to be filed with the Clerk of the Board recommending legalization of the Road, which included the survey prepared by the County Surveyor as required under ORS 368.206(1). Additionally, the Board adopted Resolution 2018-009 Scheduling a Public Hearing and Directing Notice Thereof for the Consideration of the Legalization of a Portion of SW Hewett Boulevard.
- f. County Transportation has provided notice of this April 5, 2018 proceeding in compliance with ORS 368.206(1)(c).
- g. The Board has determined that the legalization of the Road is in the public interest.

**The Multnomah County Board of Commissioners Orders:**

1. As authorized under ORS 368.201 to 368.221, that the portion of SW Hewett Boulevard, County Road No. 405, located in unincorporated Multnomah County, Oregon as more particularly described in the attached Exhibit A ("the Road"), is hereby legalized as a county road, specifically to be known as County Road No. 5025.
2. Further, as provided by ORS 368.216(2), the County Surveyor and County Transportation staff shall comply with all of the requirements of ORS 368.106(1)-(4), to perfect the legalization of the Road.

3. Upon the completion of the legalization procedures required under ORS 368.201 to 368.221, any records showing the location of the Road that conflict with the location of the Road as described in this Order are void, and the Road exists as shown on this Order.

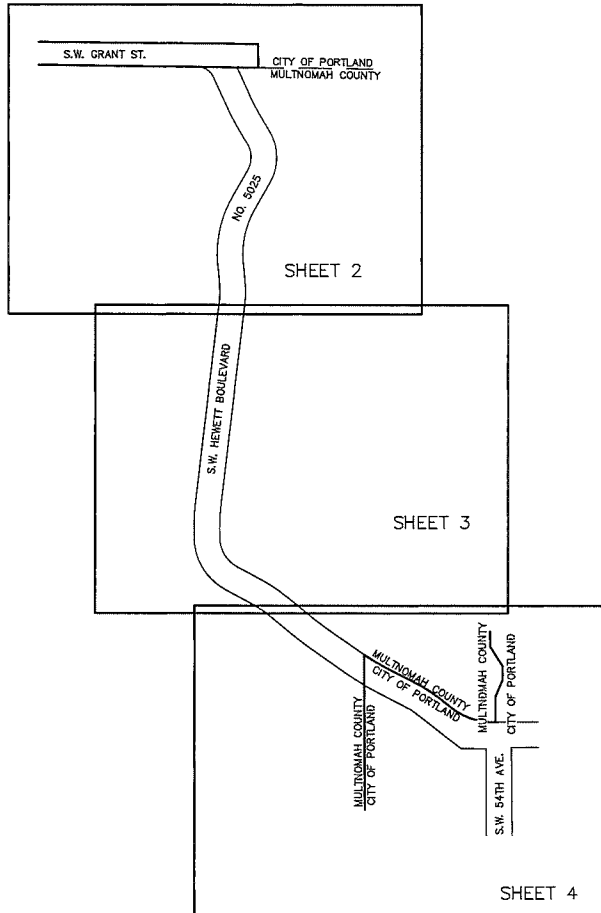

**NARRATIVE**

THE PURPOSE OF THIS SURVEY IS TO SURVEY THE EXISTING ALIGNMENT OF S.W. HEWETT BOULEVARD FROM THE CITY OF PORTLAND BOUNDARY AT S.W. GRANT STREET, SOUTHERLY TO THE CITY OF PORTLAND BOUNDARY WEST OF S.W. 54TH AVENUE, FOR LEGALIZATION PURPOSES.

S.W. HEWETT WAS ORIGINALLY ESTABLISHED AS COUNTY ROAD NO. 405 ON JULY 2, 1886 PER MULTNOMAH COUNTY ROAD BOOK 2, PAGES 159 THROUGH 167. THE IMPROVED ROADWAY, AS IT PRESENTLY EXISTS, NO LONGER LIES ENTIRELY WITHIN THE ORIGINALLY ESTABLISHED RIGHT-OF-WAY. THE COUNTY TRIED TO CORRECT THIS SITUATION IN 1931, AS SHOWN ON ROAD MAP C5/3, HOWEVER THIS WORK WAS NEVER FINALIZED. THIS SURVEY SEEKS TO REMEDY THIS BY LEGALIZING THE PRESENT AS-TRAVELED ALIGNMENT OF THE IMPROVED ROADWAY.

THE PROCEDURE USED TO CREATE THE LEGALIZED ALIGNMENT WAS TO LOCATE (TIE) THE PAVEMENT EDGES OF THE PRESENT IMPROVED ROADWAY AND HOLD THESE AS THE BASIS OF THE NEW CENTERLINE. TANGENTS WERE FITTED TO THE STRAIGHT PORTIONS OF THE ROADWAY AND GEOMETRICALLY REGULAR CIRCULAR CURVES WERE FITTED TO ACCOMMODATE THE CURVED PORTIONS OF THE ROADWAY. ROAD RIGHT-OF-WAY EXTENDS TO 30' ON EACH SIDE OF THE CENTERLINE.

A FIELD SEARCH WAS CONDUCTED FOR ALL MONUMENTS OF RECORD ALONG THE RIGHT-OF-WAY AND THOSE FOUND WERE TIED. FOUND MONUMENTS APPEAR ON THE DRAWING AND ARE DESCRIBED IN THE ACCOMPANYING MONUMENT TABLES.

THE SOUTH LINE OF S.W. GRANT STREET AT THE NORTH END OF THE PROJECT WAS DETERMINED BY HOLDING MONUMENTS (19) AND (23) PER SN 59877.

THE CITY OF PORTLAND BOUNDARY AT THE SOUTH END OF THE PROJECT WAS ESTABLISHED BY HOLDING THE CENTER OF SECTION LINE AS SHOWN ON MULTNOMAH COUNTY G.P.S. SURVEY OF T. 1 S., R. 1 E., AND RECORDED AS SN 59420. G.P.S. CONTROL POINTS WERE SET FOR THIS PROJECT IN ORDER TO OBTAIN A RELATIONSHIP TO SAJO SN 59420. A SCALE FACTOR OF 1.000090772 WAS USED TO CONVERT GRID DISTANCES TO GROUND DISTANCES. A ROTATION ANGLE OF -1°35'05" WAS USED TO CONVERT FROM GRID BEARINGS SHOWN ON SN 59420 TO TRUE GEODETIC BEARINGS ON THIS SURVEY.

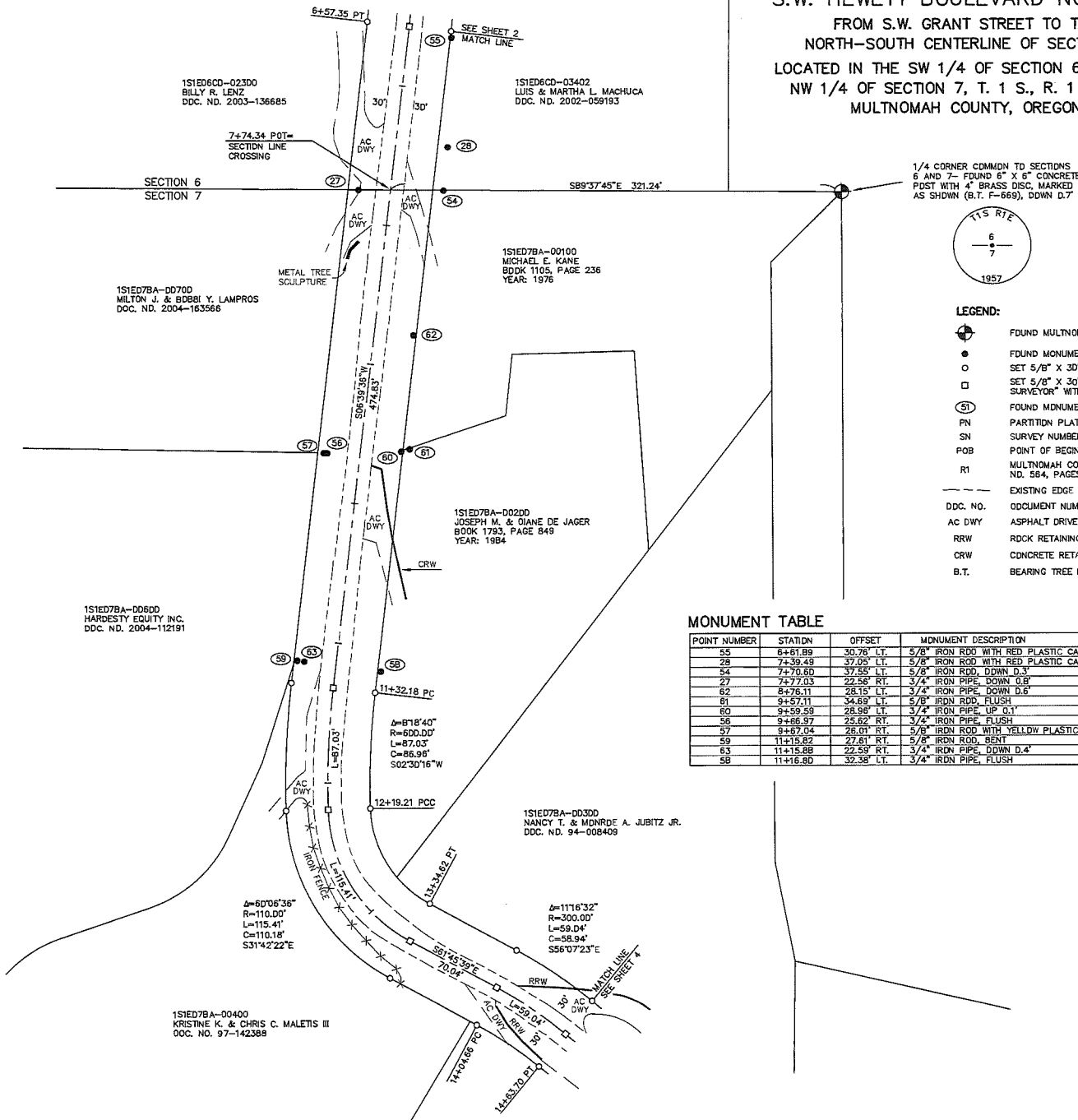

RESOLUTION NO. 2017-103

Authorizing Staff to Initiate Proceedings to Legalize a Portion of SW Hewett Blvd., County Road Number 405.

**The Multnomah County Board of Commissioners Finds:**

- a. ORS 368.201 to ORS 368.221 establishes the process and procedures the County must follow to "legalize" a county road when there are irregularities in the County's records with respect to the legal description or otherwise for the road.
- b. ORS 368.201(1)-(3) provides the authority for a county governing body to initiate proceedings to legalize a county road where doubt exists as to the legal establishment of the road due to omission or defect, where the location of the road cannot be accurately determined due to numerous alternations of the road or a defective survey of the road or adjacent property, or where the road as traveled and used for 10 years or more does not conform to the road as described in the county records.
- c. For portion of SW Hewett Blvd., County Road Number 405, the location of the road cannot be accurately determined due to numerous alternations of the road, a defective survey of the road or adjacent property, and the road as traveled and used for at least the past ten years from SW Grant Street southeasterly, about 1,800 feet to SW 54<sup>th</sup> Avenue, does not conform to the existing records for this county road.

**The Multnomah County Board of Commissioners Resolves:**

1. Pursuant to ORS 368.201, authorization to initiate proceedings to legalize a portion of SW Hewett Blvd., County Road Number 405, is hereby granted.
2. The County Surveyor is directed to survey the road to determine the location of the road and the width of the road in compliance with ORS 368.206 (1)(a).
3. The County Engineer is directed to file a written report with the governing body including the above referenced survey and any other information required by the governing body in compliance with ORS 368.206(1).
4. The County Engineer shall set this matter for further proceedings for legalization of the above mentioned county road before this Board and as required under ORS 368.206(1)(c), shall provide notice of such proceedings under ORS 368.401 to 368.426 by service to owners of abutting land and by posting.

Scheduling a Public Hearing and Directing Notice Thereof for the Consideration of the Legalization of a Portion of SW Hewett Boulevard.

**The Multnomah County Board of Commissioners Finds:**

- a. SW Hewett Boulevard was established as County Road No. 405 in 1886 and the road cannot be accurately determined due to numerous alterations of the road, a defective survey of the road or adjacent property, and the road as traveled and used for the last ten years does not conform to the existing records for this county road.
- b. On December 21, 2017, consistent with ORS 368.201 to 368.221, the Board of Commissioners initiated proceedings for legalizing SW Hewett Boulevard, from SW Grant Street southeasterly, about 1,800 feet to SW 54<sup>th</sup> Avenue, in its traveled location and directed the County Surveyor to conduct a survey of the road.
- c. As required under ORS 368.206(1), the County Surveyor has completed the survey of the road and prepared a report to the Board with the proposed new County Road Number "5025," attached here as Exhibit A.
- d. The above referenced statutes require the County to hold a public hearing to consider legalization of SW Hewett Boulevard and provide notice thereof by personal service to the abutting property owners and by posting.

**The Multnomah County Board of Commissioners Resolves:**

4. The notice shall advise that all persons interested in or concerned with the road are invited to attend the hearing.





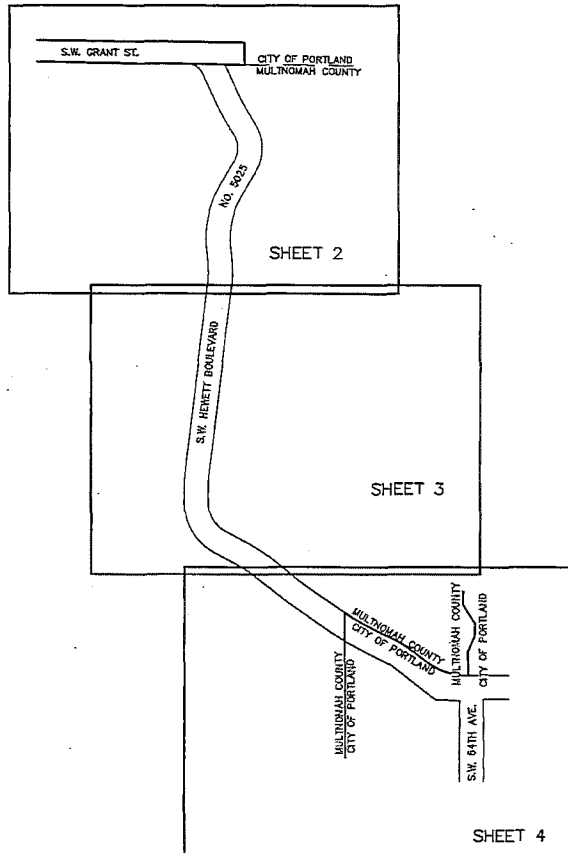

**NARRATIVE**

THE PURPOSE OF THIS SURVEY IS TO SURVEY THE EXISTING ALIGNMENT OF S.W. HEWETT BOULEVARD FROM THE CITY OF PORTLAND BOUNDARY AT S.W. GRANT STREET, SOUTHERLY TO THE CITY OF PORTLAND BOUNDARY WEST OF S.W. 54TH AVENUE, FOR LEGALIZATION PURPOSES.

S.W. HEWETT WAS ORIGINALLY ESTABLISHED AS COUNTY ROAD NO. 405 ON JULY 2, 1886 PER MULTNOMAH COUNTY ROAD BOOK 2, PAGES 159 THROUGH 167. THE IMPROVED ROADWAY AS IT PRESENTLY EXISTS, NO LONGER LIES ENTIRELY WITHIN THE ORIGINALLY ESTABLISHED RIGHT-OF-WAY. THE COUNTY TRIED TO CORRECT THIS SITUATION IN 1931, AS SHOWN ON ROAD MAP C5/3; HOWEVER THIS WORK WAS NEVER FINALIZED. THIS SURVEY SEEKS TO REMEDY THIS BY LEGALIZING THE PRESENT AS-TRAVELED ALIGNMENT OF THE IMPROVED ROADWAY.

THE PROCEDURE USED TO CREATE THE LEGALIZED ALIGNMENT WAS TO LOCATE (TIE) THE PAVEMENT EDGES OF THE PRESENT IMPROVED ROADWAY AND HOLD THESE AS THE BASIS OF THE NEW CENTERLINE. TANGENTS WERE FITTED TO THE STRAIGHT PORTIONS OF THE ROADWAY AND GEOMETRICALLY REGULAR CIRCULAR CURVES WERE FITTED TO ACCOMMODATE THE CURVED PORTIONS OF THE ROADWAY. ROAD RIGHT-OF-WAY EXTENDS TO 30' ON EACH SIDE OF THE CENTERLINE.

A FIELD SEARCH WAS CONDUCTED FOR ALL MONUMENTS OF RECORD ALONG THE RIGHT-OF-WAY AND THOSE FOUND WERE TIED. FOUND MONUMENTS APPEAR ON THE DRAWING AND ARE DESCRIBED IN THE ACCOMPANYING MONUMENT TABLES.

THE SOUTH LINE OF S.W. GRANT STREET AT THE NORTH END OF THE PROJECT WAS DETERMINED BY HOLDING MONUMENTS (18) AND (25) PER SN 59877.

THE CITY OF PORTLAND BOUNDARY AT THE SOUTH END OF THE PROJECT WAS ESTABLISHED BY HOLDING THE CENTER OF SECTION LINE AS SHOWN ON MULTNOMAH COUNTY C.P.S. SURVEY OF T. 1S., R. 1E., AND RECORDED AS SN 59420. C.P.S. CONTROL POINTS WERE SET FOR THIS PROJECT IN ORDER TO OBTAIN A RELATIONSHIP TO SAID SN 59420. A SCALE FACTOR OF 1.000090772 WAS USED TO CONVERT GRID DISTANCES TO GROUND DISTANCES. A ROTATION ANGLE OF -133°03' WAS USED TO CONVERT FROM GRID BEARINGS SHOWN ON SN 59420 TO TRUE GEODETIC BEARINGS ON THIS SURVEY.

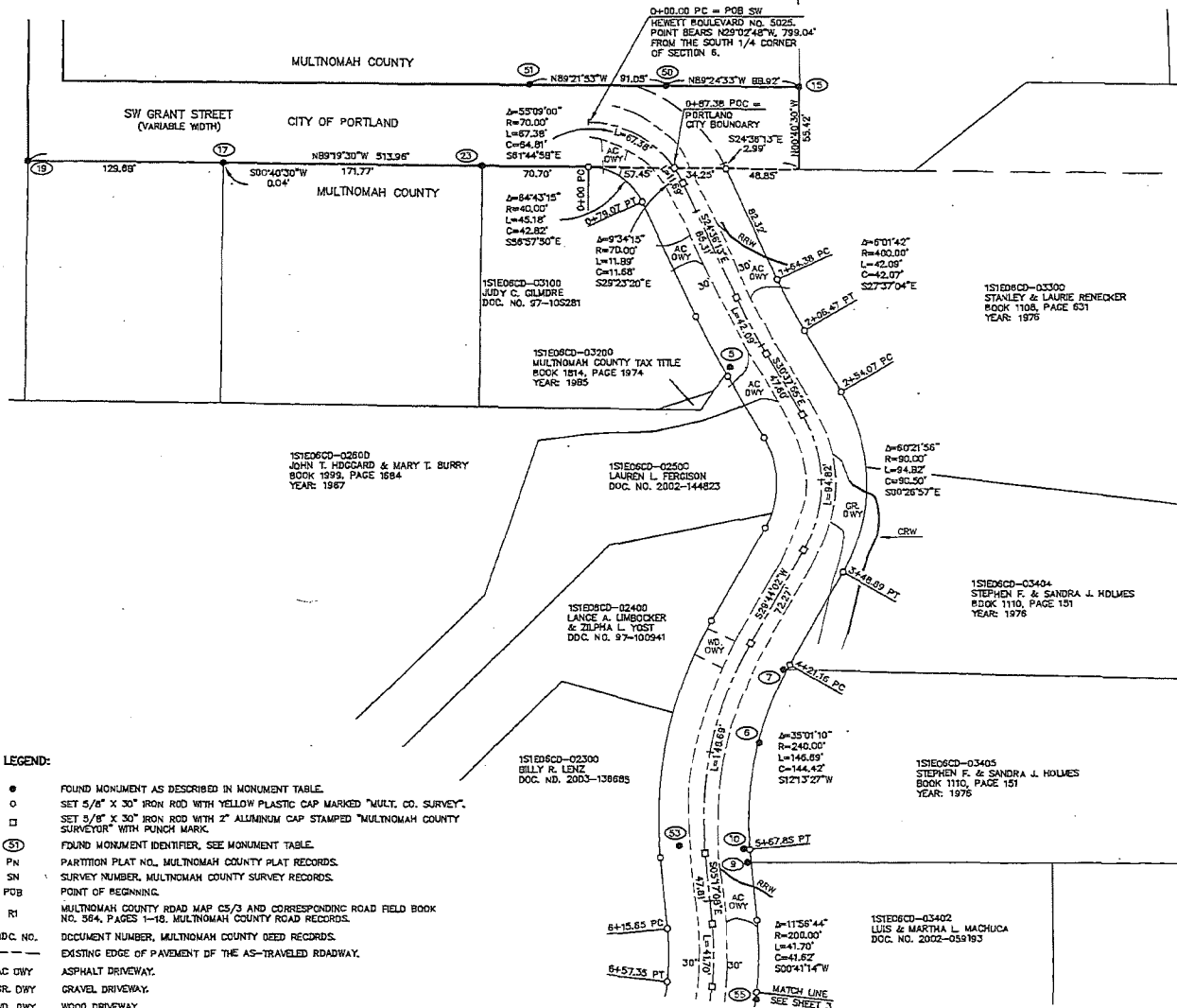

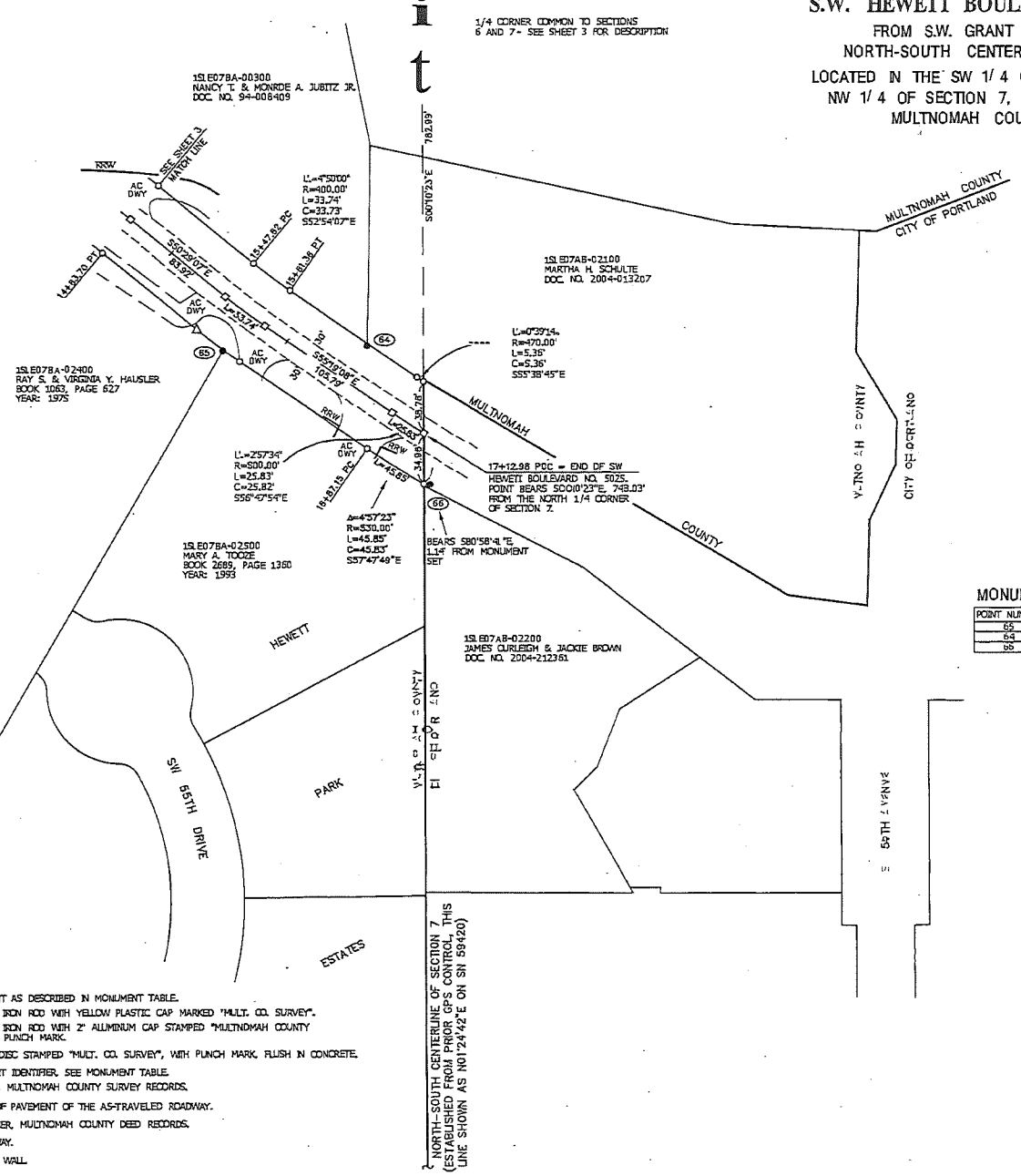

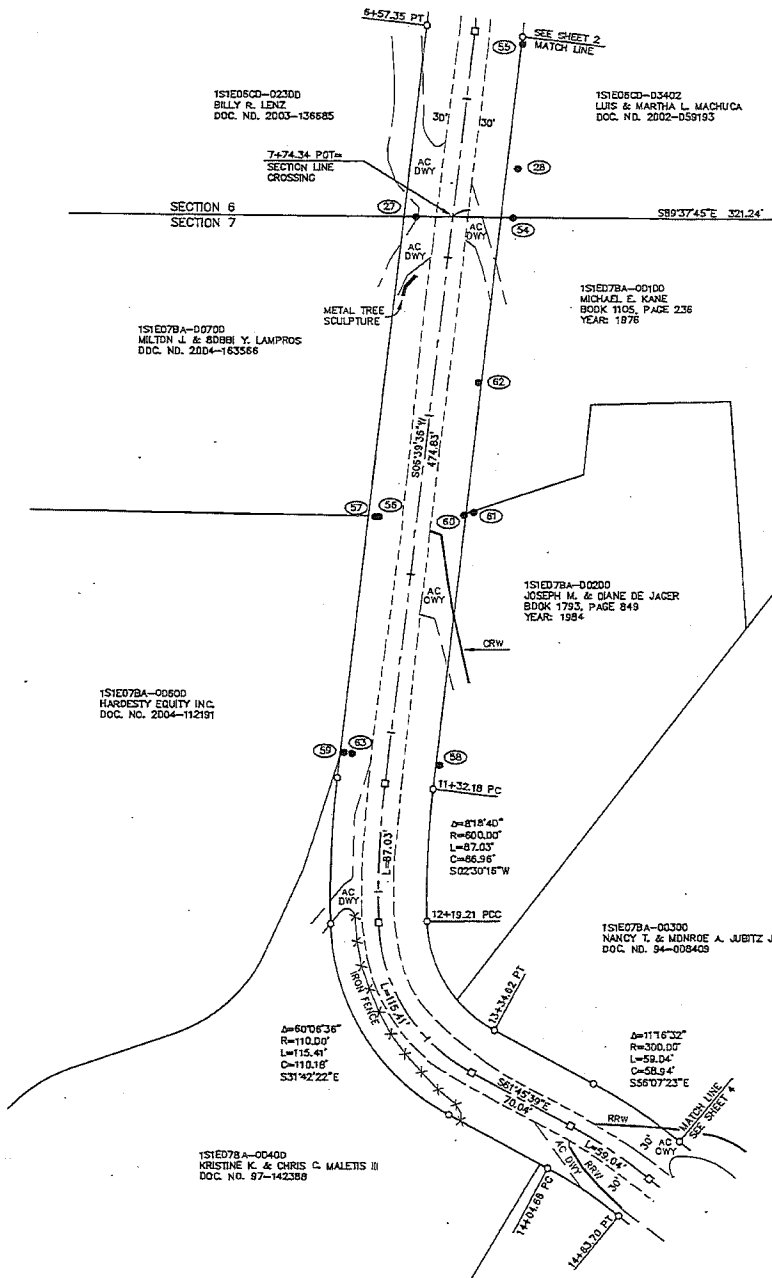
