- Tobacco- meeting with Chair Kafourey with T21(raise the age of tobacco sales to 21 from the sellers and not the individual) and etax, will get more information next month, start the conversation. FDA regulates e-cigs, you have to be 18 to purchase

Highland Haven

- Nutrition- working with 4 congregations, did follow up with Bethesda and signed MOU, meeting with 2 other congregations this week
- Tobacco- May 18th, tobacco forum with youth age 18-25, youth group at Highland, Fresh Empire campaign, shared ideas for youth campaign they plan to launch in the fall around outdoor messaging, positive imagery, using older siblings as a role model for younger ones. Wanted to get the youths get reactions and thoughts. Social media- ties to truth initiative, bringing voice of tobacco telling you what to do, using vines and celebrities making smoking looking foolish, and allowing youth to answer to tobacco. Gives a voice to young people

City of Gresham

- Community engagement report- 4 people are reviewing it and getting feedback, work with team to address concerns and then finalize report. It will be a living document, continue to add to it. We plan to have interdepartmental coordination, strategic with community engagement, how we message our projects
- Consultants from year 1, exploring retail environments- creating a business plan and operations manual, received a draft, will bring to meeting to talk about what they have been doing. Still are some gaps, grant works and development schedules are different, trying to match

We received a separate contract - Rockwood CDC to do Rockwood Rising project</li> <li>• Active transportation plan- Alta planning and design have done technical work, go out and ask people if this is what they experience, use community liaisons to develop personal networks to reach communities, 2 wider events to reach folks. More to come on the details and network approach. Should have a draft of walk, bike low stress network by Sept</li> </ul>
