SUBJECT: Outreach Subcommittee Work

BACKGROUND & PROCESS

The Community Involvement Committee (CIC) Community Outreach & Engagement Subcommittee began meeting in September 2019. The group met 7 times and decided to focus their efforts on reviewing and updating a Resolution on citizen involvement that was adopted by the Multnomah County Board of Commissioners in 1995. The Subcommittee noted the benefits of updating this language, adding in a commitment to equity and highlighting the critical role of community engagement in achieving more equitable outcomes throughout the County. The Community Outreach & Engagement Subcommittee chose to draft a resolution for commissioners to consider, with the goal of working with the Board on adopting a final document that states the County's commitment to equitable and active community engagement.

The group was able to review a handful of documents from other jurisdictions that centered on values of community engagement and equity. These documents included:

- The City of Seattle's Executive Order 2016-06 establishing public engagement and outreach principles
- The City of Portland's Public Involvement Principles, adopted in August 2010
- The City of Portland's Office of Community & Civic Life draft code change

During the CIC's January meeting, the committee aligned on values they would like to see incorporated into the new document. All agreed that equity and inclusion must remain at the forefront of a document detailing the County's commitment to community outreach and engagement. This includes addressing the history of systemic oppression, especially in Oregon,

and negative impacts and outcomes for underrepresented communities in Multnomah County, especially in communities of color. The committee feels this focus is crucial for building relationships and creating trust with historically underrepresented communities to ultimately improve outcomes. The CIC would like to see the Board adopt values that are reflective of proactive, active and consistent community engagement among all departments of Multnomah County.

The Subcommittee views this draft as having the potential to be a foundational document that highlights the County's values and approach to community engagement. Members look forward to collaborating with the Board to receive input on the draft and eventually arrive at a final document the CIC will recommend to the Board for adoption. Goals, metrics and measurable outcomes are important for creating accountability and evaluating community engagement. For the next phases of their work, the Subcommittee would like to look at how County departments measure success in community engagement.
