Viewing Assessment, Taxation and Recording Information

Information about Multnomah County's recorded documents, property values, and taxes is available through our websites:

MultcoRecords.com: View information from Multnomah County recorded documents since February, 2002. Searchable by name, date, document type, etc. Note: The actual image of the document is not shown, but a listing of the relevant information within the document such as the document type, document number, recording dates, party type, parties' names, legal description etc. Documents can be viewed in our public research area, located at 501 SE Hawthorne, Suite 175 Portland, Oregon.

MultcoPropTax.com: Multnomah County property Assessment and Tax information Searchable by owner, address, map, etc.

You can use both sites for free at DART Customer Service in the Multnomah Building (501 SE Hawthorne Blvd, Portland). Hours are 8:30 a.m. to 4:30 p.m. Monday through Friday except legal holidays. We also have microform property records and recordings predating the web sites.

MultcoRecords.com is a subscription-only site. MultcoProptax.com has a free guest log in (with limited searching); full access is available by-subscription. One sign-up covers both sites and also gives you access to purchase custom assessment and taxation data reports.

Subscribers pay a one-time account setup fee of \$150 for their company or household. You can request as many user accounts and passwords as you need. Searches cost about 25 cents each and usage is billed monthly. We will provide a usage report by-user with your invoice.
