

# MULTNOMAH COUNTY JAIL STATISTICS: JANUARY 2008

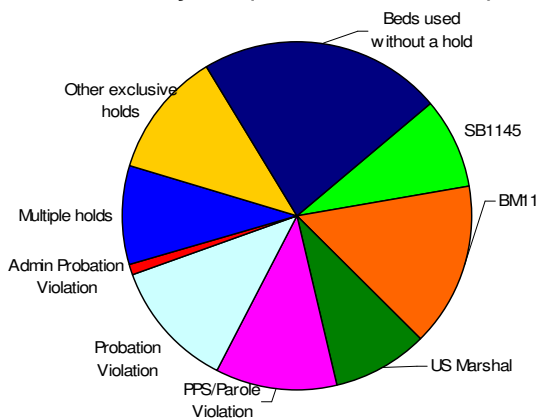
## Key Statistics<sup>1</sup>:

- The total number of average daily filled jail beds: **1534<sup>2</sup>**
- The average daily jail beds filled exclusively under the contract with U.S. Marshal's Office<sup>3</sup>: **136**  
The number of billed jail beds<sup>4</sup> under USM contract: **144**
- The average daily jail beds filled under SB1145 (Local Control population): **128**
- The average daily jail beds filled exclusively by Parole or Probation violations: **373**
- The number of Emergency Population Releases: **0**
- The number of inmates on active field-based work release (FBWR) caseload<sup>5</sup>: **37**  
The number of jail bed days saved due to FBWR: **513** (equivalent to **16.5** jail beds).
- The number of inmates referred to treatments: **48**. The number of inmates placed into treatments: **12**. Average number of inmates on February treatment waiting list: **66**
- CANS made a total of **1124** hearing notifications with **77%** call success rate. Of those who received a successful reminder, about **90%** appeared to hearings<sup>6</sup>.

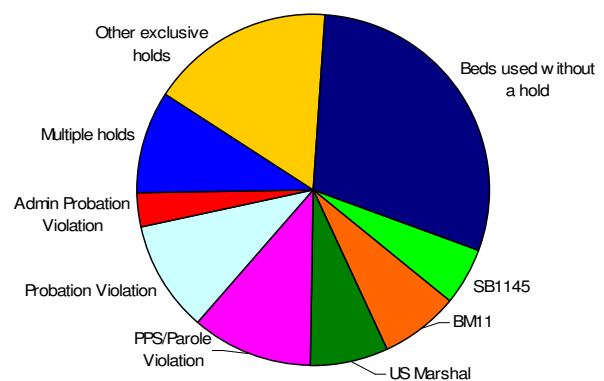

<sup>1</sup> This data sheet is provided mainly to meet the reporting requirements as specified in one of the FY 2008 Budget Notes.

<sup>2</sup> This represents 93.9% of total County operational jail bed capacity (N=1633). Capacity at 97% or higher is considered a Population Emergency. In-transit bookings were excluded from the total bed use calculation.

<sup>3</sup> This number does not include 23 non-exclusive USM beds that were reported in other categories.

<sup>4</sup> The number of billed USM beds is a result of negotiation and data reconciliation between the County and US Marshal's office. It may not be the same number as pulled out from the DSS-J system.

<sup>5</sup> FBWR caseload includes new admissions, new terminations, or cases admitted previously but still active by the end of month.

<sup>6</sup> DSSJ and OJIN data were used to calculate CANS FTA outcomes. Persons in custody at time of hearing were excluded.

<sup>7</sup> Beds used for SB1145 and BM11 (based on primary offenses) were counted first regardless other types of holding reason an inmate might have.
