

MULTNOMAH COUNTY JAIL STATISTICS: JULY 2008

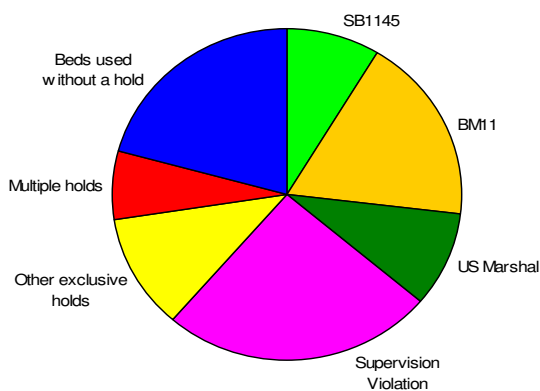
Key Statistics¹:

- The total number of average daily filled jail beds: **1,409²**
- The average daily jail beds filled exclusively under the contract with U.S. Marshal's Office³: **130**
The number of billed jail beds⁴ under USM contract: **137**
- The average daily jail beds filled under SB1145 (Local Control population): **119**
- The average daily jail beds filled exclusively by Parole or Probation violations⁵: **355**
- The number of Emergency Population Releases: **0**
- The number of field-based work release (FBWR) program participants⁶: **32**
The number of jail bed days saved due to FBWR: **712** (equivalent to **23** jail beds).
- The number of inmates referred to treatments: **31**. The number of inmates placed into treatments: **13**. Average number of inmates on the treatment waiting list in August: **50**
- CANS made a total of **3,136** hearing notifications with **83%** call success rate. Of those who received a successful reminder, about **93%** appeared to hearings⁷.

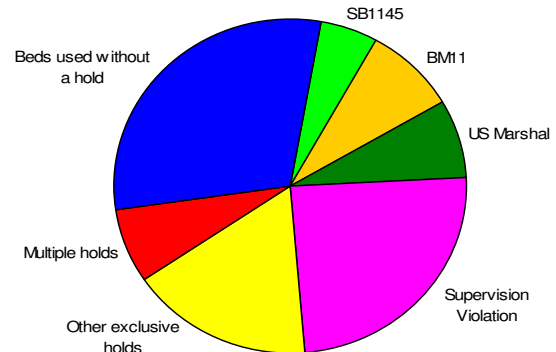

¹ This data sheet is provided mainly to meet the reporting requirements as specified in one of the FY 2008 Budget Notes.

² This represents 91.5% of total County operational jail bed capacity (N=1539). Capacity at 97% or higher is considered a Population Emergency. In-transit bookings were excluded from the total bed use calculation.

³ This number does not include 26 non-exclusive USM beds that were reported in other categories.

⁴ The number of billed USM beds is a result of negotiation and data reconciliation between the County and US Marshal's office. It may not be the same number as pulled out from the DSS-J system.

⁵ Started in May 2008, this number also includes any combinations of post-prison, parole, or probation supervision violation holds that were previously grouped in the 'Multiple Holds' category.

⁶ FBWR participants include new admission, new termination, or admitted previously but still active by the end of month.

⁷ DSSJ and OJIN data were used to calculate CANS FTA outcomes. Persons in custody at time of hearing were excluded.

⁸ Beds used for SB1145 (based on primary offenses) and BM11 (based on primary offenses) were counted first regardless other types of holding an inmate might also have.
