<p>Multco Gang Issues Update</p> <p>Lieutenant Tom McGranahan Sergeant Jami Resch Gang Enforcement Team/Gun Task Force Portland Police Bureau</p>	<p>Viewed a powerpoint on the gang situation in Portland:</p> <ul style="list-style-type: none"> • There are 806 identified gang members in Portland • Mostly Bloods and Crips • Hispanic gangs are rising (mainly drug activity and stabbings) • Gang homicides rose in 2011 • Most guns are stolen and passed to juveniles • Some are bought at gun shows. 	<p>Gresham</p> <ul style="list-style-type: none"> • 9 out of 10 incidences of gang violence are from the Crips or Bloods • There is an increase of human trafficking by gangs • Most youth enter gangs at middle school age or high school • 98% of gang members are male <p><u>Enforcement Strategy:</u></p> <ul style="list-style-type: none"> • Restaff uniform gang enforcement • Creation of the Gun Task Force • Developed precinct liaisons to GET • Aggressive investigation and prosecution of gang violence and related crimes • Collaboration with Federal prosecutors <p><u>Regional Effort:</u></p> <ul style="list-style-type: none"> • Federal Task Force • East Metro • Washington Co. • Vancouver • Multnomah Co. • Clackamas Co. <p><u>Collaboration Work:</u></p> <ul style="list-style-type: none"> • Working relationship with the Mayor's office • Administer Grants to fund street level gang outreach • Refer youth to services • Outreach workers • Parole and Probation working with GET <ul style="list-style-type: none"> ▪ Operation Cool Down partner ▪ Stop the Violence meetings ▪ GET going on more home visits with Parole and Probation ▪ Parole and Probation are regularly attending GET briefings <p><u>Gun Task Force</u></p> <ul style="list-style-type: none"> • Created October 2010 • Task Force comprised of 1 Sergeant and 4 Officers • They have recovered over 205 weapons • They review and investigate police reports with any indication of a gun or bullet is mentioned that otherwise might be passed over • Once convicted they are issued an exclusion from 3 areas of town that are identified as hot spots. Their exclusion has maps of the areas so there will be no confusion. <ul style="list-style-type: none"> ▪ A wide area of North Portland ▪ Downtown

<p>Adult Mentoring Program</p> <p>DDA Jim Hayden</p>	<p>Jim Hayden shared about a mentoring program as an outreach to gang members. The idea started with John Canda who asked the community for 100 men to talk to gang members to try and end gang violence. Groups of men walk through parks known for gang violence at a certain time each week and talk to gang members. The Faith community has taken a huge part in this.</p> <p>They have been able to ask, as part of a condition of probation (for adults), besides the normal conditions that they meet with a family mentor within 21 days. This has started with adults on misdemeanor crimes. They want to know how to do the same work to reach juvenile gang members.
