Commissioner Judy Shiprack called the meeting to order.

### **Announcements**

Representative Chris Garrett was welcomed as a new member to LPSCC's Executive Committee.

District Attorney Mike Schrunk introduced Rod Underhill as the District Attorney elect and Jeff Howes as the First Assistant to the District Attorney.

Commissioner Shiprack reminded the group that the What Works conference will be held January 11 and Executive Committee members should forward the names of people who should receive invitations to Mary-Margaret Wheeler-Weber.

Peter Ozanne said that the intergovernmental public safety budgeting process is moving forward; the workgroup is drafting a memo for LPSCC's approval outlining a process and next steps.

The Executive Committee approved minutes from the June and July meetings.

### **Fugitive Status Arrest Data**

Peter Ozanne introduced the fugitive status arrest analysis as a pilot project demonstrating the type of work that DSS-J enables.

Matt O'Keefe, LPSCC Public Safety Analyst, presented data exploring the kinds of cases or charges associated with a fugitive status and their impact on the public safety system. On average, about 20% of daily arrests in Multnomah County are associated with a fugitive status. Details of the findings, which drilled down to focus on misdemeanor level-charges, can be found in the Power Point presentation linked above. Discussion included questions clarifying the distinct way in which the court views DUI's versus open container charges, and the comment that some offenders who are repeatedly cited for open containers of alcohol and fail to appear for court dates might be more effectively served by bringing them to a facility such as the Hooper Detoxification Stabilization Center.

### **Emergency Population Release Workgroup**

Commissioner Shiprack announced the formation of a LPSCC workgroup to examine leading indicators in the public safety system for emergency population releases from Multnomah County jails. It will include representatives from the Mayor's Office, the Sheriff's Office, Police Chiefs, Public Defenders, Circuit Court, the District Attorney, the Department of Community Justice, and the Citizens' Crime Commission.

Sheriff Staton said that his office will be assessing the current Capacity Management Plan that the Board of Commissioners approved in 2010.

### **Communications Committee**

Karen Gray, Superintendent of Parkrose School District, presented a LPSCC Communications Plan for 2012-2013. The Communication Committee's recommendations for 2012-2013 include a focus on internal communications; holding a half-day Executive Committee retreat; directing the

Communications Committee to develop protocols for LPSCC's subcommittees and workgroups to communicate more effectively with the Executive Committee, and to enable the Executive Committee to monitor and assess the effectiveness of those committees and workgroups; devoting time during regular meetings to critical systemic issues, and using problem-solving methods for meetings and work sessions. The Communications Committee recommended that Emergency Population Releases be the first critical systemic issue addressed by the Executive Committee.

Commissioner Shiprack suggested that the Communications Committee's recommendations be further discussed at the LPSCC retreat.

**Youth & Gang Violence Steering Committee**
