PETE EARLEY

Author

Pete Earley is the New York Times bestselling author of *CRAZY: A Father's Search Through America's Mental Health Madness*, which tells two stories. It describes his attempts to help is college age son, Mike, after he becomes ill with bipolar disorder and is arrested. It also describes a year that Earley spent at the Miami Dade County Jail where he followed persons with mental disorders, who had been in jail, out into the community to see what sort of services they received. His book was one of two finalists for the Pulitzer Prize in literature in 2007 and has won awards from the National Alliance on Mental Illness, Mental Health America, the American Psychiatric Association and the American Bar Association. He has been invited to speak in Portugal, Brazil, Iceland and China about mental health reforms and testified three times before the U.S. Congress. He was part of a task force appointed by Virginia's Chief Justice of the Supreme Court to rewrite the state's involuntary commitment laws. Since the publication of his book, he has visited 48 states to discuss mental health reform and toured more than a hundred programs.

In a Washingtonian Magazine cover story entitled, Top Journalists: Washington's Media Elite, Mr. Earley was described as one of a handful of journalists in America who "have the power to introduce new ideas and give them currency." A former reporter for The Washington Post, he is the author of ten nonfiction books and five novels. His first book, Family of Spies: Inside the John Walker Spy Ring was a New York Times bestseller and was made into a five hour miniseries shown on CBS television. For his book, The Hot House: Life Inside Leavenworth Prison, Earley spent a full year as a reporter inside a maximum security prison. His book, Circumstantial Evidence helped lead to the release of a black man from death row after he had been wrongly convicted of murdering a white teenager in Alabama. His newest book: The Serial Killer Whisperer had the opposite impact. Six weeks after it was published, the Florida governor greenlighted the execution of a serial killer who had been on death row nearly thirty years.

TINA EDLUND

Acting Director, Oregon Health Authority

Tina Edlund has worked for the last 25 years in health services research and health policy with the Oregon Division of Medical Assistance Programs, Providence Health System, OHSU's Health Policy Institute, and with the Office for Oregon Health Policy and Research (OHPR). She became the Deputy Director for Policy in the newly created Oregon Health Authority (OHA) in July 2009 and currently serves as the Chief of Policy and Programs.

She also serves as lead staff to the Oregon Health Policy Board, a 9-member citizen board with oversight responsibilities for OHA. Mr. Roberts and his leadership team worked tirelessly with staff to address the long-standing issue of mandatory overtime. Together they have implemented a new scheduling system that has reduced mandatory overtime and improved staff-to-patient ratios throughout the hospital. Another change was the creation of the Recovery Services Department. This department is staffed almost entirely by consumers, who not only work directly with patients, but also bring balance to the treatment teams by sharing their unique perspective with other clinical disciplines. These changes, along with many more, have helped transform the Oregon State Hospital into a world-class psychiatric facility that truly inspires hope, promotes safety and supports recovery for all.

Presiding Judge, Multnomah County
